Post-16 Qualifications: Funding

At the recent AO-Forum Conference on 27 April, the Department for Education presented an update on *Post-16 Qualifications Reform*. In summary ...

Newsletter the nuts & bolts of awarding ...

Only qualifications that are necessary, high quality and have a clear purpose, will be approved for funding in future at 16-19 and for adults.

DfE are reforming the qualifications market at level 3 so that A levels and T Levels become the qualifications of choice at 16-19. However, they recognise that there will need to be other qualifications, at both level 3 and level 2 and below, to support this core offer. Qualifications at level 2 will support progression to further study/training at level 3, or support progression directly into skilled employment.

Small Alternative Academic Qualifications (AAQs) will be between 150-450 GLH, equivalent to 1 A level in size, typically to be taken in a mixed study programme alongside two A levels. Large AAQs will be between 720 and 1080 GLH, equivalent to at least 2 A levels in size.

AAQs will be approved against new funding approval criteria and in two approval cycles: cycle 1 qualifications will be taught from September 2025, with cycle 2 from September 2026. Qualifications will be approved for funding for 3 years rather than the current 12 months.

Providers will know by May 2024 which qualifications have been approved in the first cycle for delivery from August 2025. A detailed list of the subjects that will be available from 2025 and from 2026 is provided in the Guide to the Post-16 Qualifications Landscape, see link on the left.

AO-Forum: Ofqual Update

Ofqual provided an update on recent activities at the AO-Forum Conference: Last May Ofqual published guidance for **designing and developing accessible assessments**, particularly written assessments. AOs should be able to demonstrate how assessment materials commissioned since 12 November 2022 reflect this – and it is important to note that Ofqual will be monitoring the outcomes and publishing further updates as a result. Ofqual shared some interesting recent numbers:

235 AOs, 37 of which were recognised in the past year (mostly EPAOs).16,009 certifiable qualifications available to new learners.588 approved EPA standards.

T Levels: Where Are We Now?

IfATE introduced T Levels in 2020. Summer 2022 saw the first cohort of T Level students complete their courses, with a pass rate of over 92%. There are now 16 T Levels available, with 164 T Level providers who have registered around 10,200 students to T Levels in this academic year – more than double the previous year. There are over 100 new providers planning delivery of T Levels in Sept 2023.

Level 4/5 Reforms – Higher Technical qualifications (HTQs)

HTQs are level 4 or 5 qualifications that have been quality marked by IfATE to indicate their alignment to employer-led occupational standards. They can follow on from T Levels (which are Level 3) or can be taken independently. Work is also ongoing around funding, regulations & emerging skills. *Submit your qualifications for a quality-mark?* New or existing level 4 or 5 qualifications will receive a quality-mark from IfATE if the qualification satisfies their approvals criteria.
