Help! There's An Election Coming And I Want To Know What Might Happen So I Can Make Plans At My Awarding Body!

What will happen in the education sector over the coming years? If the Labour Party wins the next general election how will the landscape change? Will they tinker with vocational qualifications or apprenticeships? At the recent AO-Forum Conference on 1st May, Steve Besley of EdCentral considered the latest hints, clues and vibes buried in Labour's most recent mission statements, which include:

- "... the creation of Technical Excellence Colleges"
- "... an intention to transform the apprenticeship levy"
- "Higher paid jobs through better skills, apprenticeships and training"
- "Expand apprenticeships and skills training to spread opportunity for all"

These policy fragments provide some small insight as to the direction of travel: the word "apprenticeship" is referenced far more than "qualifications" showing where a future government's emphasis might lie, regardless of their colours. Changes to the levy would be gratefully received by many employers, but it's heartening to note that no modifications to EPAs have been mentioned as yet – which will be music to the ears of those who have invested heavily in this area.

Each party's manifesto will be published when the date of the general election is announced and AO-Forum members will be the first to hear when details are available.

With 2022/2023 certificates 27% higher than the previous year, international business is obviously in a period of significant growth. Qualification Wales – Funding Opportunities

QW are proactively seeking applications from AOs which provides a great opportunity to access a market of over three million people. There are now 91 awarding bodies recognised by Qualification Wales and this number is growing each year.

You are able to seek designation or approval for your qualifications, thereby making them eligible for use on publicly funded programmes for learners under the age of 19, and recognition provides the region's centres with the assurance that you are able to develop and offer high-quality qualifications.

Are you already regulated by Ofqual? The effort to also achieve QW recognition is relatively low as the Conditions of Recognition are very similar.
